

What do the Baby Friendly Health Initiative in Ireland National Committee and the BFHI National Co-ordinator do?

The main object for which the BFHI in Ireland is established is to benefit the community by encouraging and supporting health-promoting practices towards ensuring a breastfeeding supportive health care environment which fosters life-long health for infants and their mothers. The BFH is an independent body funded through a grant from the Health Promotion and Improvement, Health & Wellbeing Division HSE to facilitate it to provide information, support, and monitoring of standards towards assisting hospitals to provide this environment.

The BFHI National Committee

The BFHI National Committee is a multi-disciplinary group including midwives, lactation consultants, paediatric nurse, public health nurse, dietitian, hospital management, educators, mother to mother support group counsellors, and health service representatives from a variety of work settings including health promotion, hospitals, community, education and training. The BFHI National Committee has overall responsibility for the business and affairs of the BFHI. Further details are available in the Constitution which is on the BFHI web site.

National Co-ordinator of BFHI in Ireland

Dr Genevieve Becker, PhD, MINDI, IBCLC, FILCA

The co-ordinator of the BFHI provides support to hospitals, drafts Irish adaptations of international BFHI materials, compiles reports, highlights BFHI related resources, facilitates networking between hospitals, increases awareness of the BFHI in Ireland, trains assessors and coordinates the assessments, monitors practices and standards, acts as a link to BFHI internationally, represents BFHI at the National Breastfeeding Strategy Committee and generally co-ordinates the BFHI in Ireland. The grant from the Health Service Executive funds this part-time contract.

Dr Genevieve Becker, has coordinated the BFHI in Ireland since it began in 1999. She is a dietitian and International Board Certified Lactation Consultant who has worked in maternal, infant and young child feeding, particularly in breastfeeding, for over 25 years. She was a volunteer counsellor with a mother-to-mother support group for 20 years. Her main interest is the education and performance of health workers in breastfeeding supportive practices. She has earned a Masters of Science (Community Health), a Masters in Education and a PhD, which examined assessment of health worker performance in assisting mothers to learn skills related to breastfeeding. She was awarded a Health Research Board Fellowship to produce a Cochrane systematic review on methods of milk expression, and keeps it up-to-date as a volunteer. She is the first (and as yet the only) European recognised as Fellow of the International Lactation Consultant Association. Genevieve has also worked in Community Nutrition in the (then) Western Health Board and for the Department of Health Promotion, NUI Galway.

Dr Becker working through *BEST Services* was the lead was responsible for the updating and revision of the WHO/UNICEF BFHI global materials in 2006-2009 and acts as a consultant to countries establishing or revitalising their Baby Friendly Initiatives. Dr Becker participated in the World Breastfeeding Conference 2012 in Delhi that focusing on protecting breastfeeding and was the ILCA/WABA Chris Milford Fellow in 2016. Dr Becker works from an office in Galway city.
